All art work must be labeled with title, price, medium, town and name of artist on back and appropriate paperwork filed out for inventory. All artwork must be for sale, Framed or Gallery Wrapped (finished edges), wired for hanging

NO WET PAINT, SIZE LIMITATION - nothing larger than 24" in either direction

All work will be juried with no guarantees

If artwork is sold, 35% of sale will be retained for Mystic Chambers of Commerce.

_____ I understand that Mystic Chamber will encourage the sales of my artwork and will charge a 35% commission. Mystic Chamber will not release art to a buyer without receiving payment and will pay me (the artist) after the closing of the exhibition.
